It is a pleasure to learn of your interest in becoming a Corporate Affiliate member of the Metropolitan Indianapolis Board of REALTORS®.

Corporate Affiliate members shall be individuals associated with a company, firm or corporation, which are related to or have an interest in the real estate industry, but are not engaged in the real estate profession's activities of appraising, buying, selling, exchanging, renting, leasing or managing real estate for compensation.

A one-time application fee for the company of \$50.00 plus membership dues for each assigned member is to be submitted with the application. Annual dues (July 1 – June 30) for each member are \$135.00, prorated according to the submission date listed below. Applications received through the 15th of each month are submitted to the MIBOR Board of Directors for membership approval to begin the first of the following month.

Corporate Affiliate membership may be transferred within your firm. However, should an employee leave your firm, the Corporate Affiliate membership cannot be transferred with the employee. The membership may be reassigned to a new member joining your firm.
