## AWARDS CRITERIA

---

### LOCAL REALTOR® OF THE YEAR AWARD CRITERIA

- Achievement of REALTOR® during the year of the award.
- Candidate should exhibit professionalism and success in the area of real estate and Board activities. In addition, service to the real estate industry should be considered a higher priority than productivity.
- Can be nominated by a Division, Director, Officer or Member.
- Candidate cannot be a current Director or Officer.

**Consider:** Division activities, committee activities, Board involvement, IAR activities.

### LOCAL AFFILIATE OF THE YEAR AWARD CRITERIA

- Achievement with emphasis during the year of the award.
- Achievement based on Board activities and services.
- Can be nominated by Division, Director, or any member.
- Candidate cannot be a current Director or Officer.

**Consider:** Division activities, committee activities, Board involvement, IAR activities.

### BUD TUCKER COMMUNITY SERVICE AWARD CRITERIA

- Candidate must have caused a direct impact on the community outside of real estate promoting a positive image of the real estate community.
- Award does not need to be given each year.
- Can be nominated by any Member, Director or Officers.
- Must be a member of MIBOR.
- Candidate cannot be a current Director or Officer.

**Consider:** Civic, charitable activities over a long period, including leadership roles.

### DISTINGUISHED SERVICE AWARD CRITERIA

- Candidate must be active at MIBOR and in the real estate industry.
- Must have ten years consecutive service in the real estate industry (can include appraising, affiliated services, etc.).
- Award is based on continuing service to MIBOR - highest priority.
- Award can be presented to more than one person each year.
- Can be nominated by Division, Director, Officer, or any member.
- Candidate cannot be a current Director or Officer.

**Consider:** Activities over a lifetime for the Board, division, special projects, etc.

### DENVER HUTT RISING STAR AWARD

- Candidate must be active within MIBOR and within the real estate industry as a whole.
- Must have no more than 5 years consecutive service in the real estate industry (can include appraising, affiliated services, etc.). Age is not a factor.
- Award will recognize achievements and activities within the real estate industry and related community activities spanning the last 2 to 5 years.
- Award is designed to recognize one person per year, however multiple awards can be considered if warranted by the awards taskforce.
- Award need not be awarded each year.
- Can be nominated by Division, Director, Officer, or any member.
- Candidate cannot be a current Director or Officer.

**NOTE:** MIBOR Directors approve the finalists. The MIBOR Awards Team selects the award recipients from the nominations.
