

## Mailing Labels, Membership CDs & Data Export Sales Agreement and Order Form

Members of the Metropolitan Indianapolis Board of REALTORS® (MIBOR) may purchase mailing labels, as well as data exports and membership CDs containing mailing information for other MIBOR members.

### **Mailing Labels**

Mailing labels may be purchased for the following groups:

- All REALTOR® members
- All Affiliate members
- REALTOR® members in selected zip codes

COST: Mailing labels are <u>6 cents (\$0.06) per label</u> for a complete set of all REALTOR® or Affiliate members. Mailing labels for REALTOR® members in selected zip codes are <u>8 cents (\$0.08) per label</u>. A <u>\$50.00 minimum charge</u> is required for any set of mailing labels.

#### **Data Exports**

Member mailing information includes Last Name, First Name, Full Name, Firm Name, Address, City, State and Zip Code. This information is available in the following formats:

- Comma-delimited ASCII
- Tab-delimited ASCII
- · Microsoft Excel Spreadsheet

COST: Data exports are <u>10 cents (\$0.10) per record</u> for a complete set of all REALTOR® members, Affiliate members or REALTOR® members in selected zip codes. A <u>\$75.00 minimum charge</u> is required for any data export.

#### Membership CD

Member mailing information includes Last Name, First Name, Full Name, Firm Name, Address, City, State and Zip Code for all active REALTOR® members of MIBOR at the time the data is pulled. This information is available in the following formats:

- Comma-delimited ASCII
- Tab-delimited ASCII
- Microsoft Excel Spreadsheet

COST: Membership CDs are \$500.00 per CD.
